Regular Month Meeting Benton City Council October 16, 2023

The regular meeting of the Benton City Council was called to order on Monday, October 16, 2023 at 5:00 P.M. at Benton City Hall. Mayor Rita Dotson presided and called the meeting to order. Pledge of Allegiance was said and prayer was offered by Bethany Cooper.

Council Members Present: Ann Riley, Laura Craynon, Guy Henton and Rita Murray.

Council Members Absent: Kevin Farley and Butch Holland.

Other Staff Present: Bethany Cooper, City Clerk/Treasurer; Rob Mattingly, City Attorney, Logan Hampton, Police Sergeant and Todd Riley, Gas Manager

City Attorney Mattingly read the second reading of an ordinance amending Chapter 93, Section 93.40(B)(7): Sales and Use of Fireworks of the City of Benton's Code of Ordinances. A motion was made by Murray, seconded by Riley to approve. All agreed. Motion carried.

City Attorney Mattingly read the second reading of an ordinance accepting Riverside Drive as a city street. A motion was made by Henton, seconded by Craynon to approve. All agreed. Motion carried.

City Attorney Mattingly read the first reading of an ordinance amending Chapter 91: Streets and Sidewalks of the City of Benton's Code of Ordinances. This ordinance was tabled for revisions. Another first reading will be read at a future meeting.

City Attorney Mattingly read the first reading of an ordinance awarding the franchise for the collection of residential solid waste.

Mayor Dotson read a municipal order to amend Municipal Order No. 18-09-01 establishing personnel polices to amend Vehicle Use section and add Defensive Driver Training. A motion was made by Henton, seconded by Craynon to approve. All agreed. Motion carried.

City Attorney Mattingly read a municipal order to amend Municipal Order No. 18-09-01 to add a Return to Work section. Some sections need more clarification so order has been tabled until next meeting.

Mayor Dotson read a resolution accepting the grant, approving the grant assistance agreement, authorizing the amendment of the City of Benton's annual budget, and authorizing a representative to sign all related documents for Kentucky Infrastructure Authority's Cleaner Water Program for our Lift Station Rehabilitation Project (22CWS154). A motion was made by Riley, seconded by Henton to approve. All agreed. Motion carried.

Benton Gas System received the following bids to purchase a 2023 skid steer:

A motion was made by Henton, seconded by Craynon to approve the special called minutes of September 11, 2023; special called minutes of September 14, 2023 and special called minutes of September 15, 2023. All agreed. Motion carried.
