

ORDINANCE NO. 21 - 06-05

**AN ORDINANCE AMENDING SECTION 155.120(A)(7) AND SECTION 155.139(A)(8)
OF THE CITY OF BENTON'S
CODE OF ORDINANCE RELATING TO THE COMPENSATION OF THE PLANNING
COMMISSION AND BOARD OF ADJUSTMENT**

WHEREAS members of the Planning and Zoning Commission and Board of Adjustment serve an important and legally mandated function for the City of Benton that requires their attendance for monthly planning and zoning meetings as well as required semi-annual training.

WHEREAS members of the Planning and Zoning Commission and Board of Adjustment currently serve without compensation.

WHEREAS the City Council for the City of Benton desires to compensate members of the Planning and Zoning Commission and Board of Adjustment for their service.

NOW THEREFORE BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BENTON, KENTUCKY that Section 155.120(A)(7) of the City of Benton Code of Ordinances is amended to read as follows:

(7) All voting members of the City of Benton Planning and Zoning Commission shall be compensated fifty dollars (\$50.00) per meeting attended not to exceed a total compensation of six hundred dollars (\$600.00) per calendar year. Reasonable expenses lawfully incurred by the members of the Commission in the performance of their duties may be reimbursed by the City of Benton.

BE IT FURTHER ORDAINED BY THE COUNCIL OF THE CITY OF BENTON, KENTUCKY that Section 155.139(A)(8) of the City of Benton Code of Ordinances is amended to read as follows:

(8) All voting members of the Board of Adjustment shall be compensated fifty dollars (\$50.00) per meeting attended not to exceed a total compensation of six hundred dollars (\$600.00) per calendar year. In the event a member of the Board of Adjustment serves as a member of the Planning and Zoning Board, said member's compensation is limited to a total of fifty dollars (\$50.00) per meeting attended. Reasonable expenses lawfully incurred by the members of the Commission in the performance of their duties may be reimbursed by the City of Benton.
